

# Harrietsham Parish Council

Minutes of the Parish Council Meeting held on Wednesday 29<sup>th</sup> November 2023 at 7.30pm in the Booth Hall

Cllr Powell welcomed all present to the meeting.

## Public discussion

A resident requested that draft minutes be added to the website before they are approved. It was agreed that this would be considered at the January F&GP meeting. **ACTION: F&GP Cttee**

A resident queried whether there would be a Christmas light switch on and it was explained that the lights had been set on a timer and it would cost £350 to allow for this, which was not felt to be value for money. Also, with the A20 running through the middle of the 5 lights, there isn't a focal point where residents could safely gather.

A resident reported that a number of streetlights along the A20 by the West Street/Goddington Lane area are not working, which makes the junction extremely dangerous. **ACTION: Highways Cttee & Clerk**

A resident spoke regarding the Heathlands Garden Settlement and the major impact this could have on the water supply to Harrietsham, Lenham and Charing area. The wetlands, which are to be formed as part of the development, will accept sewage discharge to protect the river, but the liner to be used will breakdown over time. The concern is that there is an aquifer directly opposite the proposed wetlands, which could then become polluted and this would have a harmful impact on the water supply for the area. The resident stated that the hydrology of the area is not understood by MBC or the Planning Inspector.

## **5 Planning**

### **5.3 Other Planning Matters**

- Land South of Ashford Road Planning Appeal: Cllr Powell spoke regarding the recent appeal, where the Developer had relied on the Local Plan review as their argument. They had also stated that there would be no visual impact, due to the speed of vehicles passing the development; which had been strongly contested by the Parish Council. A decision is expected in 5-6 weeks.

- MBC Local Plan Update: Cllr Powell confirmed that the Parish Council's response to the main modifications had been submitted, which had included reiterating that Harrietsham should not be designated as a Rural Service Centre. The main issues include the waterways, M20 issues and their impact on the A20, in addition to the traffic modelling used. Once the Inspector's report is released, there would be a 6-week period in which to formally apply for a Judicial Review and this is to be discussed at the Planning Meeting on the 1<sup>st</sup> December. It was agreed to open the meeting to all members of the Parish Council.

## 6 Environmental

### 6.1 Other Environmental Matters

- Allotment Fees for 2024-2025: Cllr Brown requested that this item be discussed at the January Environmental Meeting, for a recommendation to be made. This was agreed by all present. **ACTION: Environmental Cttee**
- The Clerk reported that tree works are required around the new burial ground and Garden of Remembrance. A quote had been approved last year, however a further visit had taken place to finalise the works required and the cost has risen by approximately £100 to £760. It was proposed by Cllr Brown to accept the revised quotation and this was seconded by Cllr Roots; with all in favour. **ACTION: Amenity Manager**

Cllr Powell stated that new Planning Biodiversity Laws come into force in January 2024, with planning applications requiring a biodiversity increase of 10%. However, MBC have stated that they will want to see a rise of 20%.

This will ensure that, if an incident occurs in the future, anyone on the Parish Council could take the lead, if the Clerk and RFO/Amenity Manager were not available. **ACTION: Clerk**
